- (10)That all the conditions prescribed in the G.Os and other orders which are not specified in this orders shall be complied with.
- (11)That the school shall not be closed without giving notice both to the parents / Dist.Ednl,Officer, and the competent authority at least 6 months before.
- (12) That the school shall be closed (or) permitted to be closed only from the date on which summer vacation is declared.
- (13) That the society shall submit proposals for renewal of Provisional Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of recognition.

Now, The Deputy Educational Officer, Guntur has recommended for Extension of Temporary Recognition to Classes VI to X (E.M) from 2018-2019 to 2027-2028 vide letter 3rd read above. The District Educational Officer, Guntur District has verified the application for Grant of Extension of Temporary Recognition with reference to the Inspection Report of the Inspecting Officer and also with the reference to the conditions laid down in the permission orders and G. O.Ms.No:1 Edn.,(PS-I) Rules Department, Dt:1-1-1994 and submitted a report in his letter 4th read above.

After Careful examination of the references read above and the conditions prescribed in G.O.Ms.No: 1 Edn., Dt:1-1-1994, G.O.Ms.No. 41 Edn. Dt: 11-05-2006 and G.O.Ms. No. 74 Education, Dt: 11-09-2006 and as per the instructions issued by the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad in the reference 10th cited, the Regional Joint Director of School Education, Guntur here by accords for Extension of Temporary Recognition to Classes VI to X (E.M) for a period of 10 (ten) Years Commencing from the academic year 2018-2019 to 2027-2028 in respect of Nandi School, Pedanandipadu Village and Mandal Guntur District without aid now or in future subject to fulfillment of the following conditions. - 2. That the Educational Institution shall serve the needs of the locality more Particularly.
- That the instructions shall adopt the curriculum and syllabus prescribed from time to time.
- 4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
- 5. That the qualified staff with in the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the Staff pattern.

- 6. That the results of the Institutions shall be satisfactory every year.
- 7. That the records /accounts shall be furnished to the D.E.O every year. All the managements should submit their Annual Administration Report in the prescribed proforma to the competent authority for every financial year by 30th of September. The inspecting authority i.e the Deputy Educational Officer concerned will inspect and verify the accounts including payment of the salaries and other benefits to the staff. The managements shall cooperate with the inspecting officers during inspection
- 8. That the list of Governing body shall be furnished to the D.E.O. every year.
- 9. That the qualified staff in TET within the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the Staff pattern. Managements should ensure to Pay minimum salaries to the teachers by 1st every month through bank. All the managements should ensure to reach every benefits i.e gratuity, PF, GIS etc.,
- The Management is requested to renewal the Vehicle Fitness Certificate every year
 from the concerned authorities without fail and submits the same to the concerned
 Deputy Educational Officer.
 - 11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
 - 12. That the society shall submit proposal for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
 - 13. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
- 14 The Management is requested to submit Final No Objection Certificate from the Fire and Emergency Services Department with in 3 months.
- 15 The Management is requested to fulfill conditions stipulated in G.O. 9th read above within 3 months and submit compliance and other conditions stipulated by the Government as well as by the Commissioner of School Education, AP, Amaravathi from time to time.
- 16. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year. Management of the school should upload the fee collected by them during academic year 2018-19 in cse.ap.gov.in web and also to display in two prominent places visible to public in respective school premises without

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for Extension of Temporary Recognition for the year 2028-2029.
